Mrs. Steeper consequently asked \$10,000 damages as balm for her wounded feelings. settlement was announced. The terms were not made public, but it was learned that Mrs. Steeper received \$325 as a

recompense. SEDUCTION CASE SETTLED. Brewer vs. Coutts has also been settled. Mr. Brewer, a miller in Parkhill was the plaintiff, and George Coutts was the detendant. Coutts was formerly of Parkhill, and was engaged as an operator on the Grand Trunk. He was well connected and a general favorite. Last winter, it is alleged, Coutts seduced Miss Fanny Brewer, a pretty daughter of the plaintiff. Coutts went to Detroit, but he was induced to return. An endeavor to get the young couple married was unsuccessful and Coutts went back and is there now. Mr. Brewerasked \$2,500 damages, but he only got \$300. It is possible that the young people may yet be married.

CHARLES JACKSON'S MISFORTUNES. When the case of Charles Jackson against the Globe Casket Company was called, Mr. Cameron, for Jackson, asked several amendments to the pleadings, one being to insert the names of John Ferguson, Robert Watson and W. Coles as members of the company. The amendments were

Jackson is a married man, living at 809 Dundas street, is 37 years of age and has two young children. He is a woodturner M.P., and Mr. Gibbons, Q.C., to speak at the public meeting to be held in connection Grand Trunk shops. He was discharged together with a number of others. Since then Jackson has worked at anything he can get. In March last he was engaged by the Globe Casket Company to do laboring work. On the 24th he was digging a drain when a cave-in occurred and he was seriously injured. He claims \$5,000 damages. JACKSON'S STORY.

The plaintiff Jackson was first examined. He had been working for the company for about eight days when the accident happened. The drain was being dug in order to lower a feed pipe. Jackson was working under the direction of another laborer named Figg. He had reached a depth of five feet, and was just about finished when a teamster yelled "Look out, Charley, it is caving in ?" Jackson did not take time to look on either side, but made a bolt for a tank in front of him. "And what happened then?" asked the witness' counsel. "I got my right knee on the tank, when

a mass of earth and broken iron weighing about 1,000 pounds caved in. I was pinned fast by the hips and could do nothing to kelp myself. I COULD HEAR THE BONES BREAKING and feel them overlapping each other. I was pulled out by several bystanders and

afterwards removed home. The pain I suffered was intense." Jackson further told of the nature of his injuries. He had been confined to his bed for six weeks, and was still unable to work. He did not think he would ever be able to work again. The company had paid \$6 a week until the notice of the action was served upon them. Jackson had been offered light work by Mr. Watson, but he ould not accept it.
