A BIG INCREASE IN LONDON'S DEBT

Problem That Confronts the City Authorities.

Outstanding Debt Over \$231,000,-000-Society Has Become More Exclusive.

London, Sept. 15 .- The report of the London county council, just published, furnishes some striking figures indicating the immensity of the municipal problem with which the London authorities are confronted.

According to the census of 1901 the population of the administrative county of London was 4,536,541, while Greater London immediately surrounding the county showed an additional population of 6,500,000.

The lunacy statistics of the administrative county show an increase of 50 per cent in the last ten years, the total number of lunatics being 21,369, for which drink and business and domestic troubles were accounted to be largely responsible.

The London county council has to maintain 2,017 miles of paving, a large section of which is in a constant state of upheaval owing to the number of gas, electric and water companies having the power to open roadways.

HOUSING WORKING PEOPLE. The problem of housing the working people is dealt with on a large scale, the council acting as landlord to a population of 12,596 housed in cottages, block dwellings and various other structures. The year's working showed a net surplus of \$11,565 for these dwellings compared with a deficit of

\$5,785 for the previousc year. The council is a large owner of omnibus and street car lines, which carried last year over 118,000,000 passengers while all the omnibus lines of greater London showed the enormous total of

The city's debt statistics shows a discouraging increase, the total debt outstanding being \$231,344,355, equivalent to 124.98 per cent when the ondon to 124.98 per cent of the rateable value, against 104.64 per cent when the London county council came into exist-

The tax rate now amounts to about 361/2 cents per pound sterling. AMERICAN INVASION.

Mrs. George Cornwallis-West, who was formerly Lady Randolph Churchhas been comparing American and English society, and has come to the conclusion that the "American invasion" has worksomething of a revolution in social sphere and in dress. Socially, she thinks, the Americans have made English society more exclusive tion and left matters as they were. than it was formerly. She says the Americans have spent vast sums in entertaining and living on a scale of magnificence almost unknown before. This has led the English arbiters of fashion to adopt America's lavish ways, until only a few of the wealthiest social leaders are able to keep up the American pace. As a result many of them are unable to longer participate in the grander functions and the effect on society as a whole is towards exclusiveness.

WOMEN IN POLITICS. Mrs. West maintains that English women have a much greater opportuntiy than their American sisters to engage in public and political affairs. The English woman occupies nearly all her working hours with meetings and functions of various kinds, many of them of a semi-public nature. In politics the influence of English women is direct, whereas it is so limited among American women as to be in-

appreciable. In regard to dress, Mrs. West says the American women have not been content with spending large sums on their clothes, but have introduced so much art in fit, color and design that American make is now accepted as a guaranty of excellence.

Mrs. West contemplates, in conjunction with her son, Winston Spencer Churchill, starting a new periodical, of a more popular style than the defunct Anglo-Saxon Review, after she returns from the Delhi durbar and visits Lady Minto in Canada and relatives in New York.

LONDONERS OPPOSED TO IT

Did Not Favor Bishops' Canon Re Marrying Divorcees.

Proposed Law Was Discussed at Canadian Anglican Synod.

Montreal, Sept. 13.-In the Canadian Anglican Synod sitting in Montreal, the house of bishops enacted a canon unconditionally forbidding all remarriages of divorced people, and asked the lower house, composed of clergy and laity, to concur to make that canon law. The latter house, led by Mr. Matthew Wilson, K. C., refused, and submitted the following:

"No clergyman within the said jurisdiction shall, without submitting the material facts of the case to his sons, either of whom shall have been except that any clergyman may perform such ceremony as may be necessary to satisfy the civil law to constitute husband and wife of a man and woman who have been divorced from one another, and he may bestow a blessing upon such persons who, havng been divorced, desire so to come

together again." Mr. Wilson made a most brilliant speech, pointing out the hopeless divergence of opinion not only in the house, but among the most learned divines and highest authorities. It was impossible to hope for a decision one way or the other, and the appeal to the bishop was a middle course. He drew a forcible picture of the way in which the so-called innocent party often caused a divorce, and believed the need of satisfying both the clergyman and the bishop of the innocence of the man seeking marriage would effectually guard against the improper performance of the ceremony. seconder supported the motion because it provided a machinery for investiga-Amongst those who supported Mr. Wilson were the Very Rev. Dean

Innes, the Ven. Archdeacon Davis, the Rev. David Williams and the Rev. Prof. Clark, D.D., of Trinity University, together with a large majority of the laymen, and the proposal of the bishops was finally rejected. When the lower house refuses to concur with the house of bishops, the reasons for non-concurrence must given, and the following were put forward by Mr. Wilson: "(1) Some dissent because they don't want to force their opinions upon a minority, and, therefore, desire to make no order upon the question. (2) Some dissent because they are of the opinion that the innocent party in case of divorce for adultery is entitled by divine law to marry. (3) Some dissent because they recognize the fact that there always has been a difference of opinion in the church on the question whether our Lord meant to forbid marriage with the innocent party in a divorce for adultery or otherwise, and, therefore, think that the church in Canada should not make a definite and unqualified pronouncement such as con-

tained in clause 4 of message 32 from he upper house.' TORONTO FAIR ATTENDANCE HUNDREDS LOSE THEIR HOMES

Disastrous Results of Western Forest Fires.

NUMEROUS DEATHS REPORTED

Navigation on the Rivers Rendered Dangerous Smoke Extends Far Out to Sea

Portland, Ore., Sept. 13.-The smoke from the forest fires is becoming thicker in this city, though the fires in this vicinity practically have burned

Hundreds of people in this and adjacent counties have been made homeless and the loss in timber and farm houses will be many hundreds and thousands of dollars. The smoke hangs so thick over the rivers that navigation is hazardous and all boats are behind time. There is no prospect of rain, and until it shall come conditions will not improve.

Fire companies were called out to Irvington. The residents of South Portland have been on duty since yesterday morning. Valuable timber has been destroyed near Cobourg, Wilhoit Springs. Wendling and other points. Men at Wendling are swamping the timber in order to save it. The destruction of the village of Viola seems certain.

Mills, lumber and timber to the value of \$1,000,000 were destroyed in Chehalis county, Wash. The damage near Lentz, Ore., amounts to over \$250,000.
