AIR TRAFFIC AGREEMENT

CANADA-UNITED STATES-QUESTION AS TO EXTENSION—CORRESPONDENCE BETWEEN GOVERNMENTS

On the orders of the day:

Mr. Howard C. Green (Vancouver-Quadra): I should like to direct a question to the Minister of Transport. Press dispatches today indicate that Canada has granted to the United States an extension of thirty days to show good faith, as the report states, in connection with the bilateral air agreement. Can the minister make a statement, either today or tomorrow, with regard to this extension? At the same time will he table the notes which are indicated in the report as having passed between the two governments?

Hon. Lionel Chevrier (Minister of Transport): The hon, member telephoned notice of his question to my office about fifteen minutes ago, and I have not had time to go into it as fully as I should like to. I can, however, tell him this. The notes exchanged between the United States government and the Secretary of State for External Affairs I presume are privileged documents, and I would doubt whether the Secretary of State for External Affairs would wish to table them.
