### Orders for Returns

Hon. Gordon Churchill (Minister of Trade and Commerce): This question, Mr. Speaker, is a refurbished edition of the one asked by the hon. gentleman last session on January 29, 1958. My answer on that occasion will be the one I give now. It is as follows:

Mr. Speaker, no records such as are asked for by the hon. member are kept, and the information is not easily obtainable as it involves tracing the country of origin of components in manufactured articles coming from the United States.

That answers the first, second and third parts of the question. As to the fourth part may I say this. British companies are free to establish branches in Canada, are encouraged to do so and have done so in large numbers. The recent United Kingdom trade mission to this country had that as one of its objectives.

Hon. Henri Courtemanche (Secretary of State): Mr. Speaker, questions numbered 19, 30, 39, 46, 48, 50, 51, 57, 69, and 71 should be changed to orders for returns.

Hon. Lionel Chevrier (Laurier): May I just point out that these questions come after orders of the day and really are not on the order paper.

## Question No. 30-Mr. Martin (Essex East):

1. To what countries does Canada now export the Salk vaccine?

2. When were the first shipments of the Salk vaccine authorized for export to any receiving country?

3. How many children in Canada have received three shots of the Salk vaccine as of March 31, 1958?

- 4. What is the total financial contribution of the federal government under dominion-provincial arrangements for the free supply of the Salk vaccine, during the fiscal year ended March 31, 1958?

Has the government received representations from any group or association requesting (a) an increase in the old age security pensions to an amount of \$75 per month, payable at age 65 with a means test; (b) amendments to the old age security and old age assistance acts to permit payment of pensions regardless of the country of residence; (c) housing facilities be made available to pensioners through C.M.H.C. or some other government agency; (d) amendments to the Old Age Assistance Act to increase the allowable income to \$2,000 for married couples and \$1,600 for single persons; (e) amendments to the disabled persons allowances act to broaden the definition of a disabled person?
