4. How much of this total expenditure was spent on behalf of dependants (a) in Canada; (b) overseas?

5. What was the over-all cost per pupil of this program (a) in Canada; (b) overseas; (c) for all of them?

6. How many of these dependants were supplied with educational services (a) in schools supplied by the federal government; (b) by way of grants to existing educational institutions?

7. What was the average per pupil cost of grants made to existing educational institutions on behalf of the education of these dependants for each of the ten provinces of Canada?

8. What is the estimated over-all cost per pupil in the regular school systems of other Canadian children in each of the ten provinces?
