Mr. Trudeau: Indeed this question was raised, Mr. Speaker, and I indicated that as long as the constitutional question is not dealt with and a specific definition of the spending power in this field given, it would be difficult to make any definite promises.

We want to know what joint programs should be considered under federal jurisdiction, and which ones should not.

INQUIRY AS TO POSSIBLE ABANDONMENT OF MEDICARE

Mr. David Lewis (York South): I have a supplementary question, Mr. Speaker. Mr. Woolliams: It does not matter what it costs.

Right Hon. P.-E. Trudeau (Prime Minister): I think that the only concession the government was prepared to make on medicare which I stated openly at the conference—was that if the ten provinces could agree among themselves that medicare should not be implemented, it would not be.
