DISMISSAL OF EMPLOYEES AT U.S. BASES IN NEWFOUNDLAND

Hon. J. A. MacLean (Malpeque): Mr. Speaker, I wish to ask the Minister of National Defence a related question. Is he now in a position to answer the question put to his colleague the Secretary of State for External Affairs yesterday regarding the lay-off of civilians at U.S. defence bases in Canada?

Hon. Léo Cadieux (Minister of National Defence): Mr. Speaker, as a matter of fact I have a prepared answer here. There seems to have been a misunderstanding as to terms. The answer is that our representations to the United States authorities were successful on some points but not on all points. For instance, we were unfortunately not able to secure a lengthening of the period of notice of lay-off given to individuals, but we were successful in persuading the U.S. authorities of the need to implement their decisions in a way which would minimize hardship to those involved—for example, those living in houses on the base. In addition, as a result of our representations the United States authorities were willing to adjust the timing and scope of their announcement so as to help Canadian government departments in their efforts to assist those adversely affected.
