**Mr. Romuald Rodrigue (Beauce):** Mr. Speaker, I thank the Secretary of State (Mr. Pelletier) for being kind enough to forward a copy of his statement to us.

As he indicated, the record number of 19,000 projects submitted by student groups is proof enough that young Canadians are interested in participating in Canadian community life.

This is why I should be disappointed if some serious projects were rejected. The project screening group has an important task to perform and I hope that it will approach it very earnestly.

I thank the minister for submitting this first report to the House and I invite him once more to keep us informed in this respect.

QUEBEC MUNICIPAL PROJECTS UNDER LOCAL INITIATIVES PROGRAM—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43

**Mr. André Fortin (Lotbinière):** Mr. Speaker, I should like to take this opportunity to raise an urgent matter of national interest, under Standing Order 43.

That the minister responsible for the administration of the Local Initiatives Program make a statement on motions to explain to the House the conflicting statements made by federal and provincial representatives about allegedly approved projects and the sum of \$5 million which is supposed to be earmarked for that program, in order to elucidate the matter thoroughly.
