## PROVISION OF SAFE CONTAINERS FOR HAZARDOUS PRODUCTS

**Mr. W. M. Howe (Wellington-Grey-Dufferin-Waterloo):** Mr. Speaker, I have a question for the Minister of Consumer and Corporate Affairs which has to do with the tremendous amount of publicity he has given recently to hazardous products. According to his own admission the

people most affected are children. When does he intend to bring in regulations requiring hazardous products to be put in safe containers and bottled properly?

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): Mr. Speaker, the publicity dealt with hazardous product containers rather than hazardous products themselves. The Food and Drug Directorate, under my colleague, has already asked pharmacists to prescribe prescription drugs in safety containers. We are now working on and are on the verge of announcing a standard for a safety enclosure for liquids which, when it is perfected and meets the economic tests that must be applied, will be provided for by way of regulation.
