## GRAIN

TWO-PRICE SYSTEM FOR WHEAT—SUGGESTED EXTENSION TO ALL CEREAL GRAIN PRODUCERS

Right Hon. J. G. Diefenbaker (Prince Albert): Mr. Speaker, my question is directed to the Minister of Justice. It has to do with the two-price system for wheat. Before I ask my question, I want to congratulate him on his new portfolio, as do all from the province of Saskatchewan.

Some hon. Members: Hear, hear!

Mr. Diefenbaker: In view of the fact that a distribution of money is to be made under the two-price system for wheat, is the government prepared to have that payment made not only to the wheat farmers but also to all cereal grain producers? I ask that question in view of the fact that many farmers went out of wheat under the Lift program and therefore will not benefit as a result of the distribution. In addition, I ask the minister whether the three western Ministers of Agriculture gave him the advice that that is the way in which justice would be done and equity accorded to farmers in general?

Hon. Otto E. Lang (Minister of Justice): Mr. Speaker, I did receive comments and representations from many quarters including the Ministers of Agriculture of the three prairie provinces, farm organizations such as Unifarm and so on, suggesting a method of distribution which would avoid distorting production patterns in the short run and would also recognize production practices which have been adopted in the most recent past. I assure the right hon. member that we are giving very serious consideration to these representations.

Some hon. Members: Hear, hear!

Mr. Diefenbaker: I ask the minister whether the three Ministers of Agriculture did in fact recommend that to him? Also, when he is replying he might say when it is expected the distribution will be made.

Mr. Lang: The discussions I held with the Ministers of Agriculture were private and confidential in their nature and I cannot comment specifically upon them, although all those gentlemen have, I believe, made their personal views known to the press and those views are therefore available to the right hon. gentleman. ## TWO-PRICE SYSTEM FOR WHEAT—METHOD OF PROVIDING MONEY AND MAKING PAYMENTS

Mr. S. J. Korchinski (Mackenzie): May I ask the minister whether legislation will be brought down to provide for the acreage payment to be made or whether this will be done by way of an item in the estimates? May I also ask whether payments will be made to correspond with the crop year or with the closing of the pool accounts?

Hon. Otto E. Lang (Minister of Justice): All these questions are really linked together and require an announcement of policy in connection with timing and the technique of making payments. Such an announcement will deal with all these matters at the same time.

Mr. Lorne Nystrom (Yorkton-Melville): May I ask the minister whether he is now in a position to tell us when he will be announcing the acreage formula on which the two-price system will be based, and when the farmers can actually expect to receive some money?
