ABSENCE OF PRIME MINISTER FROM CELEBRATION OF TWENTY-FIFTH ANNIVERSARY OF UNION WITH CANADA-REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION

Mr. Walter C. Carter (St. John's West): Mr. Speaker, I rise to seek permission of the House to present a motion under the provisions of Standing Order 43 on a matter of considerable importance not only to the people of Newfoundland but to this country as a whole.

As the House is aware, on April 1 the province of Newfoundland celebrated the twenty-fifth anniversary of its union with Canada. Notably absent from the ceremonies that were held in the province commemorating the occasion was the Prime Minister (Mr. Trudeau). I therefore move, seconded by the hon. member for St. John's East (Mr. McGrath):

That the House regrets the fact that the Prime Minister of Canada did not see fit to attend the celebration and that his absence in no way represents the true feelings of this House or the government and people of this country toward the importance of the occasion and the great benefits that have accrued to Canada as a result of its confederation with Newfoundland.

### INTEREST ACT

AMENDMENT TO FACILITATE REDEMPTION OF MORTGAGES
BY MORTGAGORS

Mr. Mark Rose (Fraser Valley West) moved for leave to introduce Bill C-271, to amend the Interest Act.

Some hon. Members: Explain.

Mr. Rose: Mr. Speaker, the purpose of this bill is to enable a mortgagor to redeem the mortgage by paying the amount of principal and interest then due, plus three months further interest. In this way, unscrupulous mortgages will be deterred from introducing excessively severe penalty clauses in the small print of the contract.
