**CANADA DEVELOPMENT CORPORATION
REORGANIZATION ACT**

MEASURE TO ENACT

The House resumed from Friday, November 22, consideration of the motion of Mr. Hnatyshyn (for the Minister of Regional Industrial Expansion) that Bill C-66, an Act respecting the reorganization of the Canada Development Corporation, be read the third time and passed.

Hon. Herb Gray (Windsor West): Mr. Speaker, I rise on a point of order. I wonder if there could be a disposition on the part of the House today to have the vote just taken with respect to the Supply Motion apply to the third reading of the Bill in question, although I suppose if I do not say this my hon. friend will insist the result be reversed.

Mr. Jean-Robert Gauthier (Ottawa-Vanier): Mr. Speaker, if that is acceptable, I would like to declare my interest in abstaining with respect to the vote.
