### ATTITUDE OF FOREIGN VISA OFFICERS

**Mr. Bill Attewell (Don Valley East):** Mr. Speaker, my question is for the Secretary of State for External Affairs. This Government's strong initiative to open our doors to immigrants to help make this country grow and prosper was warmly welcomed by Canadians of ethnocultural backgrounds. How does the Minister plan to change the sometimes arrogant attitude of foreign visa officers who, for many years, have continued to block people from simply visiting Canada through a negative "screen and restrict mentality"?

Mr. Ouellet: That is a good question.

**Right Hon. Joe Clark (Secretary of State for External Affairs):** Mr. Speaker, I must say that I am a little surprised by that question because Members of this House representing opinion on both sides have come to me in very recent days to express their appreciation of the attitude that has been shown by Canadian officers serving abroad. Nonetheless, if there are particular instances where a Member of Parliament has evidence that the kind of high standard of service that is traditionally associated with the Department of External Affairs is not being delivered, I would like to receive that specific information, and I will follow the matter.

### **OCCUPATIONAL HEALTH AND SAFETY**

#### ESTABLISHMENT OF ADVISORY COMMITTEE

Mr. Rod Murphy (Churchill): Mr. Speaker, my question is for the Minister of Justice. The Government of Canada has proclaimed the Canada Labour Code changes which provide that "there shall be a council called the Advisory Committee on Occupational Safety and Health". Since the legislation requires the Government to establish this council, can the
