Mr. Deputy Speaker: The Hon. Member knows the rules about the presentation of petitions, as I presume do all Hon. Members. First they are asked to summarize very briefly what the petition is about. So far the Hon. Member has summarized the petitions, at some length in certain cases. When the petitions are on an identical subject, I ask Hon. Members to group them together. I understand her point, that she must present them to the House. That is correct. However, she may group them together and present them to the Table. Then she may tell the constituents, or whomever it is, that they were presented to the House.

**Ms.** Copps: Mr. Speaker, I will abide by your decision. However, I think the people from Calgary would like to have their voice heard in the same way as the people from Kingston or Oromocto. I suggest that lumping them together just so that I can send them a letter saying that I presented their petition is certainly not having their voices heard in the House.

**Mr. Deputy Speaker:** For the last time, I tell the Hon. Member that if she has petitions on the same subject from Calgary or different parts of the country, of course she is able to say from where the petitions come without reading the front page of each petition. That is to what I am referring.

An Hon. Member: She has her notes now.

**Ms.** Copps: Given the Chair's ruling, I should like to present a petition from the City of Calgary. It is signed by several dozen constituents who call upon the Government to revoke the unfair changes to the Unemployment Insurance Act.

Believe me, Mr. Speaker, there are several hundred more petitions which I will save for another day.

**Miss Nicholson (Trinity):** Mr. Speaker, I rise on a point of order. If you choose to ask, I think you might find disposition on the part of the House to give unanimous consent to revert to the presentation of committee reports.

Mr. Deputy Speaker: Is there unanimous consent?
