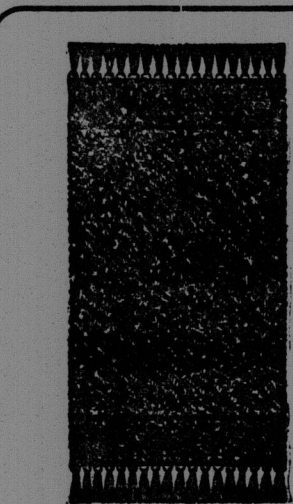

## Gould and the Matter Of Payments To Premier

"Not Out of Railway Funds," He Answered, and Protested Against Giving Further Information—Paid \$1,000 to Gleaner Because Crockett Wanted The Money—Winslow Got \$3,000 For Some Reason—The Seely Letters

A. R. Gould, president of the St. John and Quebec Railway Company, was on the stand at the Dugal inquiry all day yesterday until the commission adjourned. Another telegram was sent to New York with instructions to forward the books of the company and Mr. Gould will come when the court resumes on Tuesday morning when it is hoped that the books will be here.

Regarding the payment of \$1,000 to the Frederick Crockett, Mr. Gould said that Mr. Crockett claimed that it was for services, but his explanation was that Mr. Crockett wanted the money. The payments of \$8,000 to J. N. W. Winslow of Woodstock, he said, were for the same reason as the Gleaner payments.

When asked about the \$16,000 charged up for J. D. Seely Mr. Gould remarked, "He was another hungry customer."

A letter was produced and Mr. Gould identified it as one from himself to J. D. Seely which, he said, was in connection with Mr. Seely's suggestion that he should convey some land title to the company.

Another letter was identified by the witness as one from Mr. Seely regarding the \$16,000 transaction. A third of the same nature was identified. These letters make interesting reading. A copy of all three follows:

"No Graters or Meddlers."

St. John and Quebec Railway, Presque Isle, Me., Dec. 16, 1912.

James D. Seely, St. John, N. B.

Dear Jim,—I was detained in Montreal last week longer than I expected and only arrived home Saturday night. I saw and talked with all the interested parties with regard to the matter of settlement with Macdonnell, and I only saw him just a moment as he was coming out of the station. I did not have time to mention the subject. I would say this, however, I do not anticipate there being any trouble about your getting \$16,000 on the following conditions, as I suggested when we were in Fredericton.

First, we want to know that this amount will be satisfactory to you, and that it will be for you only.

OTHER GRAFTERS AND MEDDLERS ARE TO ENJOY ANY PART OF THE SETTLEMENT.

The settlement will be on a basis of what we consider your honest dues, and that you appreciate that we are all disposed to treat you right and do the fair thing, and of course this proposition must appeal to you as a fair and liberal attitude for the company to take, as they are not legally bound to pay anything.

While the stock certificate you hold does not count for anything, it will be required to be returned to the secretary. The next question arises as to how we are to get the money for you. While it is a simple matter to get all the money we want for construction purposes, IT IS A DIFFICULT MATTER TO GET ANYTHING FOR OURSELVES OR ANYONE ELSE OUTSIDE OF WHAT WE CAN SHOW LEGITIMATE VOUCHERS AS MONEY SPENT FOR CONSTRUCTION WORK. I DO NOT SEE HOW WE CAN POSSIBLY DO ANY BETTER THAN DRAG OUT OCCASIONAL WITNESSES UNTIL THE FIRST DIVISION IS SETTLED FOR, WHEN IF THERE IS ANYTHING LEFT, IT WILL BE EXCESS TO SETTLE ANY BALANCE COMING TO YOU. YOU MAY REST ASSURED I WILL DO ANYTHING I CAN TO MAKE THIS SATISFACTORY TO YOU.

I am obliged to return to Ottawa again tomorrow, and am not quite sure how long I shall be gone, but I expect to be down your way about Jan. 1, and about that time will endeavor to have something for you.

A.—They must have found it because it is there.

Q.—Didn't they report it to you?

A.—They did not say anything of the return.

Q.—Did the premier say that was the reason Mr. Baxter returned the \$500?

A.—I don't think he mentioned it.

Q.—Are you aware that the voucher was not given to Mr. Baxter until April 30?

A.—I do not know.

Q.—When were the Dugal charges laid?

A.—April 7.

Q.—And the committee had investigated the books before that date?

A.—Yes, about the middle of March.

Q.—Mr. Guthrie asked was any talk of the Nagle suit when you retained him. Do you remember speaking to Mr. Baxter about it?
