**Commissioner's Commendations** On May 26, 1982, S/Sgt. R. J. Grunert was presented with the Commissioner's Commendation for bravery by A/Commr. D. A. Whyte, Commanding Officer "K" Division. The recognition came as the result of an incident at Pincher Creek Detachment on October 22, 1981, involving James Earl Kilkenny, 26.

Kilkenny had taken a woman hostage earlier that evening when Pincher Creek Detachment members had attempted to arrest him for dangerous driving. Two hours later he released the hostage, then telephoned that he was coming out of the house and would blow away the first person who got in his way. Carrying a rifle, Kilkenny got into his truck. Members flattened his back tire in an attempt to stop him from driving off but this was not entirely successful — Kilkenny drove his truck to the detachment office, up over the lawn, stopping within inches of the front door. There he went on a rampage. He left the truck, blasted out the front door glass, then entered the building where he fired at S/Sgt. Grunert.
