C A P. IV.

An Act in Amendment of the feveral Acts for Regulating Juries.

**** HERAS great Inconveniencies do arife from the prefent * W Method of appointing Grand Jurors for the Supreme Court **** and Courts of General Seffions of the Peace held in the feveral Counties in this Province, and that it will greatly tend to the Eafe of the Inhabitants that the faid Grand Juries Jhould hold their Office for one Year, and ferve at the faid feveral Courts during that Time.

I. Be it Enacted, by the Lieutenant Governor, Council and Affembly, That from and after the publication of this Act, each and every Perfon, who shall be drawn as a Grand Juror at the Supreme Court, which shall herefore be held for each respective County in this Province, shall ferve as such at the faid Supreme Court and Courts of General Sessions of the Peace, during one Year from the Time of their being first fworn in at either of the faid Courts, any Law, Ufage or Custom to the contrary Notwith standing.
