(Saskatoon-Humboldt): Mr. Mr. Lang Speaker, I will be glad to bring these representations to the attention of the Minister of Agriculture.

Mr. R. R. Southam (Qu'Appelle-Moose Mountain): Mr. Speaker, I have a supplementary question for the Minister without Portfolio. I am sorry to see that the Minister of Agriculture and the Minister of Industry, Trade and Commerce are not in their places as they should be according to the roster. Will the government take under consideration the question I put two months ago to the Minister of Agriculture in which I suggested that in a similar emergency in 1959 with wheat and other grain under the snow acreage payments were made and asked whether this could not be considered now so as to alleviate the financial difficulties in which the farmers find themselves at this time?
