PROPOSED CHANGE IN DESIGNATION OF FORTHCOMING CONFERENCE

On the orders of the day:

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I should like to direct a question to the right hon. Prime Minister and ask whether, in view of the apparent broadening of the proposed federalprovincial conference originally called to discuss a bill of rights, he would in fact characterize it as a full scale conference on the constitution rather than a conference on a bill of rights?

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, I do not mind considering the changing of the name of the conference. It is true that certain very important questions have been added to the agenda. However, this would require consultation with the premiers of the provinces. I will be glad to initiate that consultation.

Mr. Frank Howard (Skeena): I have a supplementary question, Mr. Speaker. Because of the marked success of the confederation of tomorrow conference and the fact it was held in public, would the Prime Minister consider holding the coming federal-provincial conference "on camera", as prime minister Johnson put it, and not in camera?

Mr. Pearson: I think I said, Mr. Speaker, that the maximum amount of publicity should be given to a conference of this kind but, as the chairman of the conference pointed out, it was a conference which was not negotiating or discussing any proposals but at which an exchange of views took place. Right Hon. L. B. Pearson (Prime Minister): No, Mr. Speaker, there has been no discussion as yet on that particular point. I expect to hear from the premier of Nova Scotia as soon as the legislature has completed its discussion of this matter, and I have indicated to him I will be glad to see him at that time.

Mr. Douglas: I have a supplementary question for the Prime Minister. Has the government of Nova Scotia asked for any financial assistance prior to introducing legislation?

Mr. Pearson: The government has asked to meet me and representatives of the federal government to discuss the whole situation as soon as the legislature has completed its work in Halifax.
