REQUEST FOR ACTION TO MEET CONDITIONS IN SOUTHWESTERN SASKATCHEWAN

Right Hon. J. G. Diefenbaker (Prince Albert): This is a very urgent question, Mr. Speaker. I do not know who is the Acting Minister of Agriculture, so without that knowledge I direct my question to the Prime Minister. It has to do with the very serious floods which have occurred in southwestern Saskatchewan. I see the Prime Minister motioning to one of his cabinet members and therefore I now have the designation. I ask the Minister of Manpower and Immigration, who I gather is Acting Minister of Agriculture in view of his designation by the Prime Minister, what action is being taken to meet the very serious flood conditions in southwestern Saskatchewan? According to the oldtimers they are the worst in history. Further, are the facilities of P.F.R.A. being made available to municipalities and to the province of Saskatchewan in order to keep to a minimum the damage that would otherwise take place?

Hon. Allan J. MacEachen (Minister of Manpower and Immigration): Mr. Speaker, in this short-lived moment as Minister of Agriculture I would like to take the question as notice.

Some hon. Members: Oh, oh.

There will be a meeting of house leaders this afternoon at which time we will discuss the possibility of also dealing tomorrow with item No. 17, the report stage of Bill C-153, to amend the Historic Sites and Monuments Act. On Wednesday in any event we would call the report stage of Bill C-150, the omnibus Criminal Code bill. It would be our intention to remain on it for the balance of the week until its conclusion.

We will also be discussing with the house leaders the possibility of arranging a special debate, very likely on Wednesday and Thursday of next week, when the Secretary of State for External Affairs has returned, for the purpose of discussing the statements with regard to NATO. I will be making a further announcement in that regard.

EXPORT DEVELOPMENT CORPORATION

MEASURE TO PROVIDE INSURANCE. GUARANTEES AND LOANS TO DEVELOP TRADE

Hon. Otto E. Lang (for the Minister of Industry, Trade and Commerce) moved that Bill C-183, to establish the Export Development Corporation and to facilitate and develop export trade by the provision of insurance, guarantees, loans and other financial facilities, be read the second time and referred to the Standing Committee on Finance, Trade and Economic Affairs.
