GREAT LAKES POLLUTION

Mr. Bill Blaikie (Winnipeg-Birds Hill): Mr. Speaker, my question is directed to the Minister of the Environment. The Minister will be aware of reports by her own Department which show that pollution in the Great Lakes is much worse than we thought it was, and even then it was bad. Could the Minister tell the House what plans she has to accelerate the process by which the Great Lakes and the Niagara River, in particular, can be cleaned up? Will she be making any special representations, as of now, with this new knowledge, to the United States to have the \$150 million which was cancelled for sewage treatment restored, and on various other things which the Americans could be doing to get serious about cleaning up this important environmental problem?

HERRING-GULL EGG PROGRAM

Mr. Bill Blaikie (Winnipeg-Birds Hill): Mr. Speaker, we are aware that we have a promise of a plan by the fall, not a promise of action. So that the Minister is better able to ensure that that plan is translated into action soon, will she undertake to reinstate fully, not partially, not one out of six, the herringgull egg program which she cancelled last fall and which has made our credibility on Great Lakes pollution weaker than it has to be?

It is being said that pollution in the Niagara River has increased, but we must not forget that under the previous Government, only two types of effluents were analyzed, the industrial and municipal type. We are now analysing many

more kinds of effluents using far more sophisticated techniques, and now we must find out whether there really has been an increase. If so, we shall certainly inform our U.S. colleagues accordingly.

CANADA DEPOSIT INSURANCE CORPORATION

GOVERNMENT POSITION

Mr. Jean-Guy Guilbault (Drummond): Mr. Speaker, my question is directed to the Minister of State (Finance).

Considering recent bank failures and bearing in mind that since 1983, bank deposits have been guaranteed up to a maximum of \$60,000, and considering the inflation factor, does the Minister intend to amend the Canada Deposit Insurance Corporation Act to enable the Corporation to guarantee deposits up to a maximum of \$100,000?

LEVEL OF GOVERNMENT FUNDING

One of the more profound statements in yesterday's Green Paper was that all industrialized nations saw technology and innovation as the most critical elements in today's economic equation.
