Mr. Ernie Epp (Thunder Bay—Nipigon): Madam Speaker, in our continuing consideration of amendments to Bill C-93, this particular group includes some small changes in total bulk but represent very significant attempts to strengthen the Bill.

If it is in order, I would like to recognize the presence in the gallery of the President of the Canadian Ethnocultural Council and the past President. Of course, it is not in order, so I note that, in considering the motions before us here seriatim, Motions Nos. 10 and 11 are provided for in part by changes that were made in the legislative committee. My Motion No. 11 is designed to ensure that Clause 3(2) would read: "It is further declared to be the policy of the Government of Canada that all institutions shall—"

The Bill as reported from the legislative committee was amended to read "shall" rather than "should".

Having mentioned the Canadian Ethnocultural Council a moment ago, may I say that this is one of those very important points that this national organization of ethnocultural communities emphasized was necessary. The Bill initially was encouraging, but an absolute commitment was required by the Government of Canada to take strong action. That was
