Debate was resumed on the motion of Mr. Macdonald (Rosedale), seconded by Mr. Jamieson,—That Bill C-32, An Act to impose a charge on the export of crude oil and certain petroleum products, to provide compensation for certain petroleum costs and to regulate the price of Canadian crude oil and natural gas in interprovincial and export trade, be now read a second time and referred to a Committee of the Whole.

After further debate the question being put on the motion, it was agreed to on division.

Accordingly, the Bill was read the second time, considered in Committee of the Whole and progress having been made and reported, the Committee obtained leave to consider it again at the next sitting of the House.

The Order being read for the third reading of Bill C-22, An Act to amend the Canada Pension Plan;

Mr. Sharp for Mr. Lalonde, seconded by Mr. Macdonald (Rosedale), moved,—That the Bill be now read a third time and do pass.

After debate thereon, the question being put on the motion, it was agreed to.

Accordingly, the Bill was read the third time and passed.

The Order being read for the consideration of the report stage of Bill C-4, An Act to amend the War Veterans Allowance Act and the Civilian War Pensions and Allowances Act, as reported (with amendments) from the Standing Committee on Veterans Affairs;

By unanimous consent, the motion standing in the name of Mr. Marshall, as follows:—That Bill C-4, An Act to amend the War Veterans Allowance Act and the Civilian War Pensions and Allowances Act, be amended by deleting lines 1 and 2 at page 14 being Sub-clause 11(1) and substituting the following:

"11. (1)(a) Paragraph 31(3)(b) of the said Act is repealed and the following substituted:

"(b) who served in the United Kingdom during World War I for at least three hundred and sixty-five days prior to the 12th day of November, 1918: notwithstanding the foregoing requirements of this paragraph, a former member of His Majesty's Canadian forces who has served less than the minimal period so required but otherwise meets the requirements shall be deemed, for the purpose of authorization and payment of an allowance, to be a Canadian veteran of World War I save that the amount of the allowance, having been calculated as if the veteran has served in the United Kingdom at least three hundred and sixty-five days, shall be reduced pro-

portionately to an amount calculated on the ratio that three hundred and sixty-five is to the number of days in fact so served."

(b) Paragraph 31(12)(b) of the said Act is repealed." was withdrawn.

On motion of Mr. Sharp for Mr. MacDonald (Cardigan), seconded by Mr. Macdonald (Rosedale), the Bill was concurred in at the report stage and by unanimous consent, read a third time and passed.

The Order being read for the second reading and reference to a Committee of the Whole of Bill C-27, An Act to amend the Customs Tariff;

Mr. Sharp for Mr. Turner (Ottawa-Carleton), seconded by Mr. Macdonald (Rosedale), moved,—That the Bill be now read a second time and referred to a Committee of the Whole.

After debate thereon, the question being put on the motion, it was agreed to.

Accordingly, the Bill was read the second time, considered in Committee of the Whole, reported without amendment, concurred in at the report stage, read the third time and passed.

## (Proceedings on Adjournment Motion)

At 10.00 o'clock p.m., the question "That this House do now adjourn" was deemed to have been proposed pursuant to Standing Order 40(1);

After debate the question was deemed to have been adopted.
