SIX ATTEMPTED SUICIDES

Good Friday Fruitful in Tragedy at Philadelphia.

PHILADELPHIA, April 14.—Six persons, five men and one woman, attempted to commit suicide here today. Two of the men were successful. Emil Stebe, aged 42 years, a dealer in artificial flowers, killed himself with a revolver. He had been in ill-health. Gustave Orberman ended his life with gas because his wife had deserted him.

James Straub and Charles Carr, each tried gas but failed.

Miss Dianora Wylie, aged 50, a wealthy woman, tried to commit suicide with gas. She had been in poor health.

Thomas P. Bailey, of Camden, attempted to hang himself in his cell when arrested for intoxication.

EDITOR EURNED TO DEATH.

CLAREMONT, N.H., April 14.—Samuel Henry Corey, editor of the Narrator, a weekly publication, met a tragic death today. While apparently asleep on a sofa in his apartment, a fire from an overheated stove communicated to the furniture and burned him to a crisp.

Story lived alone in his newspaper office, and according to his own statement lived on nine cents a day. He was one of the oldest publishers in the state, having been born in 1823. He had relatives so far as known.
