SUGGESTED INCREASE IN CHILD CARE TAX DEDUCTION-MOTION UNDER S.O. 43

Hon. Flora MacDonald (Kingston and the Islands): Madam Speaker, I rise on a matter of pressing necessity. The child care tax deduction of \$1,000 for working mothers has not been adjusted since 1976, even though child care costs have soared to \$2,500 a year in government-subsidized centres and even higher in the private sector. Given that child care costs are a legitimate business expense and should be treated as such for tax purposes, I move, seconded by the hon. member for Provencher (Mr. Epp):

That the \$1,000 tax deduction limit for child care which working mothers can now claim be increased to reflect the legitimate costs of child care which are currently running on average at four times that amount.

STATUS OF WOMEN

FUNDING FOR NATIVE WOMEN'S FIGHT FOR JUSTICE AND EQUALITY—MOTION UNDER S.O. 43

Mr. Jim Manly (Cowichan-Malahat-The Islands): Madam Speaker, all sides of this House have recognized the blatant discrimination against native women in Canada and the urgent need for action to end it. Above all, native women need a strong organization of their own to represent their interests at local, provincial and national levels. A consultation process with the Native Citizen Directorate identified several areas for expansion of the native women's program, and a cabinet submission was to be made in early March. However, nothing has happened, and the Native Women's Association of Canada has not been able to obtain a meeting with the Secretary of State (Mr. Regan) to discuss their needs. I move, seconded by the hon. member for Nanaimo-Alberni (Mr. Miller):

That this House instructs the Secretary of State to arrange an early meeting with the Native Women's Association of Canada in order to arrange an adequate funding program so that native women will have the means to fight for justice and equality.
