


> Bassett did try to isolate her remarks to those she felt were attacking her. "I do wish however, that not all councilors feel this in a negative tone or that it is a statement to all councilors. Many of you have been very supportive of me, have helped me, and have stood by my decisions, and have expressed concern for me. I would like to thank you and want you to know that I do recognize who you are, but to mention your names might make you isolated just as I was."

Bassett closed with a plea to the students: "you should ask questions, of you [sic] councilors, you should show more interest in where you [sic] money is going ... Find out if you really are
