In all measures that it may be deemed advisable to adopt, which have a tendency to advance the general interests of the Province, and to promote the happiness and prosperity of His Majesty's Subjects, you may be affured of my ready and zealous co-operation.

Ordered, That Mr. Uniacke, Mr. Fairbanks, Mr. Lawson, Mr. Smith and Mr. Chipman, be a Committee to prepare an Address in answer to His Honor's Speech.

Ordered, That Mr. Lawson, Mr. Smith, Mr. Albro, Mr. Fairbanks and Mr. J. R. Dewolf, be a Committee of this House for the purpose of examining the Public Accounts, jointly with a Committee of His Majesty's Council, and that the Clerk do acquaint the Council therewith.

Ordered, That Mr. Fairbanks, Mr. T. Dickson and Mr. Chipman, be a Committee to examine into, and report on, the expiring Laws.

Ordered, That Mr. Uniacke, Mr. Flemming, Mr. Wier, Mr. O'Brien, Mr. Fairbanks, Mr. Kavanagh and Mr. W. Young, be a Committee of Privileges.
