The total number of Medical Examinations passed upon by the Medical Board for the year ending 1st December,

1895, was 28 956, of whom 25,951 were passed, and 3,005 were rejected.

FOR YOUR FAMILY.-5. Funeral Benefit, \$50. 6. Mortuary Benefit of \$500, \$1,000, \$2,000r. \$3,000. \$4,000 or \$5,000.

The cost of admission to the Order in most Courts is only \$7 to \$11, according to the amount of Benefit taken besides Medical Examination Fee, which is \$1.50 if you are taking \$5,000, or \$1,000 of mortuary benefit, \$2 if taking \$2,000 or \$3,000, and \$1 if taking \$4,000 or \$5,000.
