Your Managers beg to report that three proposals were made at the conference with respect to Bill No. 107. The first was made by the Senate Managers and the other two by the Managers of this House:—

1. That the legislation should be in force for one year from the 11th of November, 1918, being the date of the Armistice;

2. That the legislation should be in force until the end of the present fiscal year, that is to say, the 31st March, 1920;

3. That the Bill as passed by the House of Commons be concurred in with a proviso that upon the application of the Lieutenant Governor in Council of any province to the Governor in Council asking that an order of the Governor in Council be made repealing the regulations incorporated in the Bill with respect to such province after peace has been proclaimed, or after such date thereafter as may be stated in such application, the Governor in Council should make such order; and that upon the making of the order the regulations and any amendments thereto should not apply to or be in force in such province, or with respect to such province or any business therein, after peace had been proclaimed or after such date thereafter as might in the said application and order be mentioned.

The Managers of the conference were, however, unable to effect any agreement in the premises.

Sir Thomas White then moved, That this House doth insist on its disagreement to the amendment made by the Senate to Bill No. 107, An Act to confirm the Order in Council of the twenty-fourth day of February, 1919, prohibiting the Importation, Manufacture and Transportation of Intoxicating Liquors, and the Order in Council of the twelfth day of April, 1919, in amendment thereof; and that a Message be sent to the Senate to acquaint their Honours therewith.

And the question being put on the said motion; it was agreed to.

A Message was received from the Senate informing this House that the Senate had passed the Bill No. 177, An Act to amend the Judges Act, with amendments, which are as follows:—

1. Page 1, line 22.—In clause 3, leave out the first two lines and substitute therefor the following:—

"3. The first five lines of section nine of the said Act are repealed and the following are substituted therefor."

2. Page 2, line 5.—In clause 4, leave out the first three lines of the clause and substitute therefor the following:—

"4. The first ten lines of section ten of the said Act, as enacted by chapter twenty-eight of the statutes of 1918, are repealed, and the following are substituted therefor:---"

3. Page 5, line 15.—At the end of clause 13, after "Act" insert, "by more than five hundred dollars."

By leave of the House,-

Sir Thomas White moved, That the House do now return to Government Orders; which was agreed to.

The amendments made by the Senate to the following Bills, were respectively taken into consideration, and severally agreed to, viz.:--

Bill No. 160, An Act to amend the Criminal Code.

Bill No. 177, An Act to amend the Judges Act.

Bill No. 153, An Act to amend The Canada Grain Act.

The Bill No. 180, an Act to provide for the completion after the declaration of peace of work begun and the final determination of matters pending before the Com-57436-35
