1. Whether Mrs. Emma Rioux alias Mrs. Joseph Rioux, widow, heard as a witness in an inquiry held in connection with political partisanship in which Johnny April, postmaster of Gironde, county of Temiscouata, Quebec, was the person charged.

2. Whether said Mrs. Rioux was appointed postmistress replacing said

Johnny April.

Also,—Return to an Order of the House of the 16th May, 1932, for a Return showing:—

1. Whether Pierre Fortin lodged a complaint against Joseph Morneau, postmaster of Ivry, county of Temiscouata, Quebec.

2. Whether said Pierre Fortin was appointed postmaster to replace said

Joseph Morneau.

3. Whether he was appointed after a regular inquiry was held.

And also,—Return to an Order of the House of the 16th May, 1932 for a Return showing:—

1. Whether Isidore Ouellet lodged a complaint against Narcisse Ouellet, postmaster of Lamy South, county of Temiscouata, Quebec.

2. Whether said Isidore Ouellet was appointed postmaster to replace said

Narcisse Ouellet.

Mr. Weir (Melfort), a Member of the King's Privy Council, presented,—Return to an Order of the House of the 9th May, 1932, for a copy of all letters, cables or other communications between the Dominion Cerealist, Ottawa, and Mr. W. A. Wilson, London, England, relative to the securing of reliable cargo samples of wheat for growing test purposes.

Mr. Stewart (Leeds), a Member of the King's Privy Council, presented,—Return to an Order of the House of the 11th April, 1932, for a copy of all papers, correspondence, reports and paysheets, giving in detail the name of each person employed and the amounts paid for labour as well as the amounts paid for material, and the names of the persons from whom it was purchased, in connection with the building of wharves at Point Tupper, and at Louisdale, Nova Scotia. And also the same information with regard to repairs or extensions to wharf at Pouleamond, Nova Scotia. And also the same information regarding the extension or repairs of breakwater at Lardoise, Nova Scotia.

The Bill No. 91, An Act to amend the Judges Act, was read the second time, considered in Committee of the Whole, reported without amendment, read the third time and passed.

The Bill No. 41, An Act to amend the Bankruptcy Act, was considered in Committee of the Whole, and progress having been made and reported, the Committee obtained leave to consider it again at the next sitting of the House.

By leave of the House, on motion of Mr. Bennett, the House reverted to Routine Proceedings.

Mr. Matthews, from the Select Standing Committee on Banking and Commerce, then presented the Fifth Report of the said Committee, which is as follows:—
