Mr. OLIVER: What is the meaning of this?

Mr. WHITE: I am sorry I am unable to give the information at this moment, but I will look into the matter.

Mr. OLIVER: My hon. friend can place the information on the table.

Mr. WHITE: I wish to call the attention of the House to an item which was passed yesterday, and to which the right hon. the Prime Minister referred: the grant of \$2,500 to assist the Canadian branch of the St. John Ambulance Association. The House will remember that the Prime Minister stated that he thought it was the first time the grant had been made. My recollection was that a grant had been made in the main Estimates for 1912-1913, and on looking these up I found it to be so. The appearance of the item in the supplementary estimates represents a departmental error, and on concurrence I shall ask that the item be struck out.

Mr. LEMIEUX: There was no objection to the grant. Attention was merely called to the fact that my right hon. friend was creating a precedent.

Mr. WHITE: I quite understand. The dropping of the amount has no relation to the discussion of yesterday, except in so far as it drew my attention to the grant in the main estimates.
