GEORGIAN BAY AIRCRAFT LTD.

Question No. 148-Mr. Chevrier:

1. Did Georgian Bay Aircraft Limited apply for a class 4 charter commercial air service (with group aircraft)? C

2. If so, on what date? 3. With what type of aircraft? 4. From what bases?

5. Was the application granted?6. If so, on what date?

7. By virtue of what authority?

Hon. George H. Hees (Minister of Transport): Mr. Speaker, the answer to part 1 is yes.

With regard to parts 2, 3 and 4, Georgian Bay Airways Limited applied to the air transport board on October 17, 1958 for a licence to operate a class 4 group C charter commercial air service from a base at Belleterre, Quebec, and on April 27, 1959, applied for licences to operate class 4 group C charter commercial air services proposing to use aircraft of the Cessna 180 type from bases at Fort George, Quebec, South Porcupine and Moose Factory, Ontario.

With respect to parts 5, 6 and 7, the application in respect of Belleterre was granted by board decision, serial No. 1241, dated March 10, 1959, and the application in respect of South Porcupine was granted by board decision, serial No. 1272, dated May 21, 1959, both pursuant to government policy with respect to the licensing of services to be operated with small light aircraft in the group C category.

Question No. 149-Mr. Chevrier:

1. Did Georgian Bay Aircraft Limited apply for a class 4 chapter commercial air service (with group B aircraft) to the air transport board?

2. If so, was a public hearing held?
3. Where and on what date?

4. What was the decision of the air transport board?

5. Did Georgian Bay Aircraft Limited make a new application for the same service following the decision of the board?

6. If so, on what date?

7. Was the application granted? 8. If so, on what ground?

Hon. George H. Hees (Minister of Transport): In reply to part 1, Georgian Bay Airways Limited initially applied to the air transport board on April 27, 1959 for licences to operate class 4 charter commercial air services with group B aircraft from bases at Fort George, P.Q., and South Porcupine, Ontario.

With respect to parts 2, 3 and 4 of the question, a public hearing was held by the air transport board at Timmins, Ontario, on October 15, 1959, and the board, by decision serial No. 1359 dated December 1, 1959, denied the applications.

In reply to parts 5, 6 and 7, Georgian Bay Airways Limited reapplied to the board on December 21, 1959, for authority to operate charter services with groups B and C aircraft from bases at Moose Factory, Ontario, and Fort George, P.Q., and with group B aircraft in addition to group C from a base at South Porcupine, Ontario. The applications were granted by board decision serial No. 1370 dated January 21, 1960.

With respect to part 8, they were granted in accordance with government policy in respect of the licensing of services to be operated by aircraft in the groups B and C categories.
