INTERNAL ECONOMY COMMISSION

Right Hon. L. B. Pearson (Prime Minister) presented the following message from His Excellency the Governor General:

BUSINESS OF THE HOUSE

STATEMENT AS TO LEGISLATION TO BE CONSIDERED

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, I indicated on Thursday that I would make a short statement today on motions in regard to the business for the next few weeks.

Today, as the house knows, we will be dealing with certain farm legislation, and if that should be completed provision has been made for the rest of the day. After this legislation we will deal with the legislation regarding redistribution. I said on May 15 that we as a House of Commons, would be in default if we failed to provide for redistribution, now long overdue, in accordance with the census taken some three years ago.

After the redistribution legislation, Mr. Speaker, we will introduce legislation arising out of the report of the royal commission on transportation. This is a very important and complex matter and we are anxious to get it to a committee as quickly as possible.

Then, Mr. Speaker, we will introduce legislation to establish a Canada pension plan. A draft of the bill for this purpose is ready. This is one of the most important and complicated legislative measures, I think, ever introduced into this House of Commons.

a federal pension plan which, in conjunction with provincial legislation and with provincial co-operation, can operate as one nation-wide pension system. A careful review of every single clause of this legislation is essential, and careful consultation with the provinces in respect of all these clauses is going on, but the bill will be ready and the review completed when we get to it in the house after the legislation I have mentioned.

Then, Mr. Speaker, from time to time we will have to interrupt the legislative program to deal with supply. By the end of this month we will be half way through the financial year. On Thursday and Friday of this week, therefore, we will deal with estimates. Next Monday there will be a supply motion which will take up Monday and Tuesday, with the one remaining supply motion to be brought forward a week or two later. A week from Thursday and Friday, the 24th and 25th of this month, we will be on estimates again.

Some time in October, if not earlier, the report of the flag committee will be received; that report will be submitted to the house without delay, and a decision will be taken on this matter.

That is the program ahead, always subject, of course, to change if an emergency makes such change necessary.

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, this is the first occasion on which the house has received a report as to the legislation that will be brought before it. I was interested in the reference to redistribution, and I welcome the announcement. However, it is not in accordance with the report that was given by the premier of Saskatchewan to the effect that after having talked over this matter with the Prime Minister, he had been assured that redistribution would not be in effect for the next general election.

In so far as the pension plan is concerned, I think it is rather regrettable that it will not be introduced a little earlier so that a committee of the house could be set up and sit while the house is sitting.
