**SHIPBUILDING**

**REMOVAL OF ARBITRATION CLAUSE FROM SHIP TENDERS**

Treasury Board has decided that until such time as a firm policy pertaining to arbitration in connection with all government contracts is established between the government, the Canadian Construction Association and the Canadian Shipbuilding and Ship Repairing Association, use of arbitration clauses should be discontinued.

**Mr. MacEwan:** A supplementary question, Mr. Speaker. Is the minister aware that in the tenders called for the new D.D.H.'s this clause is included? The minister used to be head of the department; is he aware that this clause is included in those tenders?

**Mr. Speaker:** Order, please.

**Mr. Hellyer:** Mr. Speaker, this matter comes under the jurisdiction of the Minister of Industry.
