INVESTIGATION OF MISLEADING ADVERTISING

Question No. 2,166—**Mrs. MacInnis:**

Is the Combines Investigation Branch of the Department of Consumer and Corporate Affairs investigating misleading advertising practices of car and appliance leasing companies?

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): In reply to questions asking whether inquiries have been instituted under the Combines Investigation Act, the general practice is that no information is given out as to whether a particular inquiry has been or is being pursued with respect to a particular group or company unless or until a report is published or some legal proceeding of a public nature is taken. If the Honourable Member has any information or evidence which indicates to her that there may have been a violation of the Combines Investigation Act, this information should be sent to the Director of Investigation and Research.

*QUEEN'S PRINTER—POSITION OF ROGER DUHAMEL

1. Was Roger Duhamel the Queen's Printer as of May 1, 1969?

2. If not, when did he cease to occupy that position?

3. No. Mr. Duhamel was appointed by the Governor-in-Council as Queen's Printer under the provisions of the Public Printing and Stationery Act, Revised Statutes Chapter 226, Section 5. This Act was repealed on the coming into force of the Government Organization Act, 1969 (Bill C-173) on April 1, 1969.

4. Yes. Mr. C. B. Watt, Director General of Printing and Publishing in the Department of Supply and Services, has been appointed Acting Queen's Printer effective April 1, 1969.
