MOTION TO ADJOURN UNDER S.O. 26**HOUSING**

EFFECT OF ANNOUNCEMENT RESPECTING
URBAN RENEWAL

Mr. John Gilbert (Broadview): Mr. Speaker, I ask leave, seconded by the hon. member for Greenwood (Mr. Brewin), to move the adjournment of the House under Standing Order 26 for the purpose of discussing a specific and important matter requiring urgent consideration, namely, the government's announcement of yesterday which has torpedoed urban renewal and destroyed any hope of coping with the critical problems facing our cities, making it urgent that Parliament deal immediately with the situation that has now been created before the government completely abrogates its responsibilities to Canada's urban people.

Mr. Speaker: The hon. member has given the required notice to the Chair of his intention to move this motion under the terms of Standing Order 26. I have studied the motion carefully. I suggest to the hon. member and to the House that in the weeks ahead there will be a number of opportunities for the House to debate the policy statement made by the minister yesterday. All things considered, in the

ORAL QUESTION PERIOD**AIR TRANSPORT**

RATIFICATION OF AGREEMENT BY TRAFFIC
CONTROLLERS

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I should like to ask the President of the Treasury Board whether he is in a position to inform the House if there is any indication that the agreement between the government of Canada, the Department of Transport and the air traffic controllers is to be ratified?

Hon. C. M. Drury (President of the Treasury Board): Mr. Speaker, I think the House is aware that an agreement between the negotiating teams on both sides was entered into and is subject to ratification by the membership of the Air Traffic Controllers Association. This ratification is by means of balloting carried out at the various places of employment of the controllers across Canada, and the balloting is now in progress. It is not expected that all the results will reach Ottawa prior to either late tonight or early tomorrow. Until such time as these results come to the headquarters of the association, it will not be possible to ascertain whether the agreement has been ratified.

Mr. Stanfield: A supplementary question, Mr. Speaker. May I ask the President of the Treasury Board whether the government has any plans to put before the House in the event that the vote should prove to be unfavourable? We hope it will not be unfavourable.

Mr. Drury: Mr. Speaker, I do not think one would be justified in assuming that the vote will be unfavourable. There have been some newspaper stories to the effect that there has been adverse balloting. Until we know the results I think it would be unwise as well as unsafe for us to assume that it will be adverse.

Mr. Stanfield: May I ask a further supplementary question, Mr. Speaker. Is the Government House Leader prepared to consult with the other House Leaders, with a view to reaching an understanding as to the mechanics that may be followed to enable the House to sit tomorrow, for example, if that should become necessary?
