**ORAL QUESTIONS****POLLUTION**BRUSSELS INTERNATIONAL CONFERENCE—  
CANADIAN POSITION RESPECTING  
ARCTIC WATERS

**Hon. Robert L. Stanfield (Leader of the Opposition):** Mr. Speaker, may I direct a question to the Prime Minister. At the Brussels International Legal Conference on Maritime Pollution will the Canadian position with respect to the north be based upon the assertion of Canadian sovereignty over all the waters between the Canadian Arctic islands and the Canadian mainland? Will the Canadian position at the Brussels International Legal Conference on Maritime Pollution be based on that ground?

**Right Hon. P. E. Trudeau (Prime Minister):** Mr. Speaker, it will be based on the position that I have stated in my answers to previous questions by the hon. member: that Canada asserts its claim to as large a part of the Arctic waters as is possible and is proper. However, we have not yet instructed our minister in Brussels to put any lines on a map.

**Mr. Stanfield:** A supplementary question, Mr. Speaker. Are we to infer from the Prime Minister's answer that Canada will be attempting to negotiate at this international conference without making it clear what our area of sovereign responsibility is?

**Mr. Trudeau:** Yes, Mr. Speaker, because the conference is involved precisely with international waters and the minister will be discussing Canada's role and its desire to participate
