Does the federal government employ Dr. Gabriel Saab and, if so (a) is he employed by the Department of Agriculture (b) what is his status (c) what is his annual salary?

Hon. H. A. Olson (Minister of Agriculture): Dr. Gabriel Saab is (a) under contract with the Economics Branch, Canada Department of Agriculture for the period October 8, 1970 to March 31, 1971, to (b) co-ordinate special projects in the Province of Quebec related to agricultural adjustment requirements, with a salary of (c) \$2,000 per month—contract maximum, \$12,000.

*LINKING OF SPECIAL DRAWING RIGHTS TO DEVELOPMENTAL FINANCE

Question No. 904-Mr. Fairweather:

Does the government share the view of the Committee on International Development, headed by the Right Honourable Lester B. Pearson, that the linking of Special Drawing Rights (SDRs) to development finance would be a useful new aid possibility and, if so, what steps has Canada taken to obtain acceptance of this idea by other governments?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, the government has not yet arrived at a final position on the feasibility and desirability of establishing a link between special drawing rights and development finance. We do, however, regard it as an important proposal requiring serious consideration.

[Mr. Olson.]

The question was considered both at the last annual meeting of the Commonwealth Ministers of Finance in Cyprus and the last annual meeting of the International Monetary Fund and the World Bank in Copenhagen. It is also under current review in various international institutions such as the IMF and UNCTAD. We ourselves will be giving the matter further careful thought and will be participating in the various international discussions. We would hope in this way to obtain a clearer view of the complex and significant issues involved and to determine the extent to which there might be general international support for establishing a link.
