(a) obtained a certificate of continuance under the Canada Business Corporations Act; and

(b) legally committed itself to pay interest at a rate of not less than 11 per cent on any of its bonds, notes, mortgages, debentures or debenture stock which had been issued prior to 1897 and each of its subsidiaries has made a legal commitment to pay interest at a rate of not less than 11 per cent on any of its bonds, notes, mortgages, debentures or debenture stock which have been issued prior to 1897 and in each case payable in the same currency and at the same times as previously payable."

- (i) in respect of the 1983-84 crop year, 5% of the volume-related variable costs,
- (ii) in respect of the 1984-85 crop year, 10% of the volume-related variable costs,
- (iii) in respect of the 1985-86 crop year, 15% of the volume-related variable costs, and
- (iv) in respect of the 1986-87 and subsequent crop years, 20% of the volume-related variable costs:

and substituting the following therefor:

""estimated eligible costs" in respect of any crop year means an amount equal to the aggregate of the volume-related variable costs of the railway companies for the movement of grain and their line-related variable costs for grain-dependent branch lines."

In any event, I ask, Mr. Speaker, that you seek the unanimous consent of the House to waive notice so that the motion that I just read can be placed on the Order Paper for debate and consideration at report stage of Bill C-155, an Act to facilitate the transportation, shipping and handling of western grain and to amend certain Acts in consequence thereof.
