(3) Does the Government consider that this, the oldest and largest responsible boys' organization, is not as worthy of support as some of the hippy and activist groups already supported?

(4) Could the Deputy Government Leader explain to this chamber why the submissions of March 1971 of the Boy Scouts of Canada to the Department of the Secretary of State suggesting 116 projects covering 10 provinces, for the total value of \$185,000 and involving 180 boys for the benefit of 12,000 other boys, did not even receive the courtesy of an acknowledgement?

These questions have been in the form of a letter from the Secretary of State, dated June 23, 1971, which read as follows:

In answer to your letter of June 16, 1971 regarding the Honourable Senator Molson's question to the Honourable Senator Langlois in connection with the Opportunities for Youth Program, I wish to inform you that the total amount of money allocated for the Program is correctly \$23.4 millions. Those projects, submitted by the Boy Scouts of Canada that we accepted are:

"Camp Lloaskite" by the 18th Scout Group in Calgary, Alberta amount: \$12,125.

"Project Beachhead" by the 100th Rover Crew in Windsor Ontario amount: \$5,380.

With regard to the third question I wish to point out that the federal Government recognizes the validity and worthiness of the Boy Scouts Association. In this respect, the Citizenship Branch provides annually grants up to \$15,000 plus the moneys made available to them through the Young Voyageur program. The Department of Health and Welfare also provides them with substantial grants.

In respect to the Opportunities for Youth Program, all projects submitted were studied on an individual basis and evaluated according to their compliance with program criteria, which included the involvement of young people in the development, management and evaluation of projects, the provision of benefits to the community and the development of new services. In addition, the cost per job was considered, as was the regional and subregional distribution of jobs. All projects submitted were considered on the same basis and rated on these criteria. You can be assured that all projects submitted prior to the April 15th deadline were given careful and serious consideration and were analyzed within these criteria.

In answer to the fourth question, in view of the large number of applications received, totalling some 13,000, telephone contacts were used rather than written acknowledgements; I was also assured that several discussions were held between officials of the Boy Scouts Association and the Opportunities for Youth Program.

Hon. Mr. Langlois: It was written by the Secretary of State to the Leader of the Government in the Senate (Hon. Mr. Martin).
