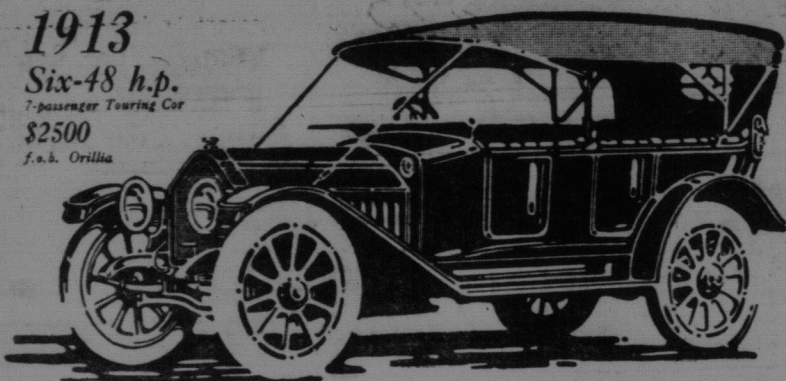

"Sophia said we were not doing anything to get money. She said she had met a rich man and wanted me to go out with her to meet him and another man."  
"Con" was furious at this. He said I did not have to make money that way. I was washing dishes at the sink. I heard a fall. I went into the bedroom and Sophia was lying there. My husband said to me, "Hurry, let's get our things and get out before she gets comical."  
"We did not know she was dead. Con never meant to kill her."  
The confession said the pair then fled with \$40 which they took from Miss Singer's effects and two suits of clothes belonging to W. H. Worthen. Miss Singer's fiancé. They went to Hammond, Ind., in a street car and from place to place until they reached Lima, Ohio.

While the alleged confession was being written from the woman, her husband covered in a cell, hearing the screams and pleadings of his wife, but he did not know what was going on and was denied the privilege of speaking to anyone. The police expect him to break down soon and make a statement. The assertion from the woman that she was married to Conway will be verified, as if she is his wife she cannot testify against him.

## COMMENDS MOVE TO MODERNIZE THE PORT OF HALIFAX

Sir Thos. Shaughnessy Speaks of Necessity of Harbor Development—Improvements to N. S. Section of C.P.R.

Montreal, Nov. 1.—Sir Thomas Shaughnessy in speaking of the Minister of Railways' announcement at Halifax, stated that the promised improvements would certainly be a good thing for that city. Sir Thomas stated that the shipping people had always recognized the fact that such facilities were necessary to the development of the port of Halifax and such being the case, the railway facilities would also be improved.

When the Canadian Pacific had secured the road they found that the large bridges were in a very bad condition and they were now being rebuilt and this would not doubt be followed by re-tracking the road with heavier rails and bringing the whole line up to the C.P.R. standard.

## GREEKS AND BULGARIANS OFF TO WAR

George Chaggaris Left Last Night for Scene of Fighting—Bulgarians Drop Pick to Shoulder Rifle.

The successes which have rewarded the efforts of the soldiers of the Balkan states in the present war has raised the enthusiasm of the local Greek colony to the fever pitch and if it were not for several restrictions all would at once proceed to the seat of war. As it is five St. John Greeks are at present fighting for their country and should the tide turn all would go home to fight.

The present condition of affairs, however, has proved too much for the fighting blood of George A. Chaggaris, who owns a poolroom and tobacco store on Dock street, and some time ago he sold his store to a cousin of the same name. In company with Peter Ventris of Milwaukee he left last evening for New York, where he will take ship for his native land. It is understood that had peace reigned Mr. Chaggaris would have returned to Greece just the same, but with the intention of being a principal in a happy event. However, if he escapes the Turkish bullets he will carry out his original plan.

Bulgarians Pass Through.

Looking forward to sharing in the successes and glory accruing to the Bulgarian army, 20 former soldiers of Bulgaria passed through the city yesterday from Fredericton on their way to New York where they take ship to their native land, and at once hasten to the regiments at the front.

The party was under the command of Serg. Yovovich, who, when seen by a Standard reporter, said that he and his countrymen came to Canada several years ago and have since been working on railroad construction in New Brunswick. He said they had just left the Valley Railway near Fredericton. During the time spent in the province they saved enough money to pay their passage to the old country and to buy arms with which to kill Turkey.

One of the men, who had an unpronounceable name, said that he fled from that portion of Bulgaria which before the war, was under Turkish control and that he had fled from home after his wife and family had been killed by a marauding party of Turkish soldiers. When speaking of such matters this man became very excited and angry and showed an ugly scar on his arm which he said had been received while defending his family.

## INSPECTOR DEFENDS THE INTERDICTION LAW

J. B. Jones Replies to Criticism Made at Thursday Night's Meeting of Associated Charities.

In reply to a statement made at the meeting of the Associated Charities on Thursday evening, that the interdiction law here is little or no good, and that an interdiction, if he wants liquor, can get it, J. B. Jones, liquor license inspector, when asked said that such a statement was not based on a knowledge of the real facts.

"It is true," he said, "that in some cases an interdiction has procured liquor through the medium of another, but the number of cases where the interdiction law has proved of value is greatly in excess.
