Ordered, That Mr. Lawson, Mr. Albro, Mr. Wells, Mr. R. Dickson and Mr. Flemming, be a Committee for the above purpose.

Then the House adjourned until To-morrow, at twelve of the Clock,

Thursday, 11th March, 1824.

PRAYERS.

Mr. Speaker acquainted the House, that, in a Communication with His Excellency the Lieutenant-Governor this morning, His Excellency was pleased to inform him that he would be in the Council Chamber this Day, at Three of the Clock, for the purpose of proroguing the General Assembly.

On motion, refolved, That a Committee be appointed to wait upon His Excellency the Lieutenant-Governor, to state to His Excellency, that the House have had under its consideration the Communication from Earl Bathurst relative to the Windsor and Dalhouse Colleges, which was transmitted by His Excellency to this House.

But that as it is the intention of this House, in the next Session of the Assembly, to give a very general consideration to the subject of Education, in which those Institutions will necessarily be brought under discussion, they have found it necessary to defer the further consideration of his

Lordship's Communication until that period.

Ordered, That Mr. Archibald, Mr. Dewolf, and Mr. O'Brien, be a Committee for the above purpose.

An Engrossed Bill for appropriating such part of the Supplies, granted in this Session of the General Assembly, as are not already appropriated by the Laws or Acts of the Province, was resd a third time.

Resolved, That the Bill do pals and that the title be, An Act for applying certain Monies therein mentioned, for the service of the year of Our Lord One Thousand Eight Hundred and Twenty-four; and for appropriating such part of the Supplies granted in this Session of the General Assembly, as are not already appropriated by the Laws or Acts of the Province.

Ordered, That the Clerk do carry the Bill to the Council, and desire their concurrence.

On motion, refolved, That should the Bill, entitled, "An Act to make further provision for the equal Administration of Justice in the Province of Nova-Scotia," which has passed this House and been agreed to by His Majesty's Council, pass into a Law, the Speaker do apply, during the recess of the House, for a Writ for the Election of one fit and proper Person to represent the County of Sydney, in the place of John George Marshall, Esq. and that in case any other vacancy shall happen by reason of any appointment to be made under the said Act, the Speaker do apply for a Writ or Writs to have the same filled pursuant to Law.

Mr. Haliburton reported from the Committee appointed yesterday to wait upon His Excellency the Lieutenant-Governor with Copies of the several Resolutions of the House, on various subjects, in answer to Communications from His Excellency to this House, that the Committee pursuant to order, had accordingly waited upon and delivered to him, the said Resolutions, and that His Excellency was pleased to express his approbation of the same.

Mr. Archibald reported from the Committee appointed this day, to wait upon His Excellency the Lieutenant Governor, on the subject of the Resolution of this House in answer to the Communication of Earl Bathurst to His Excellency relative to the Windsor and Dalhouse Colleges, that the Committee had accordingly waited upon and delivered to His Excellency a copy of the said Resolution.
