Antrim.

A serious strike, which will affect about seven thousand men, is threatened in the Belfast shipbuilding and iron trade. The masters have notified that, owing to the depression in trade, a reduction of is, per week in wages will be made after September 1st. The men have held various meetings with the employers on the subject, and at a mass-meeting, on July 6th, decided by a large ma-jority to resist the reduction. The matter has assumed a serious aspect, as both parties are determined not to give way.

The deceased, who was on a visit to his son, who is a Protestant clergyman, was much-respected; and general grief is felt at his death.

Cork.

Derry

A drowning fatality under extraordinarily melancholy circumstances took place in Derry, on Sunday evening, July 2d. A number of boys were bathing at a place known as the Scotch Quay. One of their number got beyond his depth, and was apparently sinking, when a boy named George Margey, aged 13 years, jumped in to his rescue, and had got the drowning boy on his back; and was bravely swimming with him to the shore, when he took cramps and sank. Hands were set grappling for the recovery of the body, but up to the present it has not been recovered. The other boy got out of the water all right.

Donegal.

In the Court of Appeal, on July 4th, the of the Court of Appeal, on July 4th, the case of Sir William Stewart, landlord; Davidson, tenant; was heard. This was an appeal against the order of Land Commission dismissing the tenant's application to have a fair rent fixed on his holding near the town of Ramelton, on the ground that it was a town park. It was proved that the farm, which consisted of eight acres, held at a rent of £1419s. 3d., had been occupied by the tenant, in conjunction with a large farm, as permanent pasture. The Court confirmed the decision of the Land Commission, dis The Court confirmed missing the application on the ground that it was not an ordinary agricultural farm.

Down.

A deplorable accident took place on the evening of June 30th, on Killinehy road, about two miles from Killyleigh. A man named Anderson, a rougher in Comber Spin ning Mill, was seated on a cart, accompanied by a man named Allen, and driving from Comber to Killyleigh. Owing to some cause as yet unknown, he fell off the cart, striking the ground with his head, and received such fearful injuries that he died the same evening. Allen was placed onder arrest, but was subsequently released on bail. The sad affair is much regretted by the people of the neighborhood, where the deceased, who belonged to Comber, and who was married and leaves a wife and one child, was well known. Deceased was 27 years of age.

Kerry.

A curious scene occurred recently, at the meeting of the Listowel Town Commission-The Commissioners had, at a previous meeting, passed a resolution to exclude the Press from all future meetings, and they asked a reporter who was present to leave. The reporter declined to go, and the police were called in with the result that the meeting came to a premature end amid much confusion, the police not recognizing that they had any right to remove the repre rentatives of the press from what should be an open meeting.

Louth.

A man named John Phillips, a well-known car driver of Dundalk, died suddenly on June 29th, at the residence of his sister, Mrs. Mary Hanlon, Bachelor's walk. He called there about noon and asked for a drink of buttermilk, saying he was not well. When he had drank some he moved over to the foot of the stairs and sat down, dying in a few minutes. It appeared that Phillips had been for twelve months under the care ef Dr. Callan, suffering from fatty degeneration of the heart, combined with other organic diseases. He was a man of about 60 years of age. The coroner knowing the circumstances of the case, did not consider it necessary to hold an inquest.

Mayo.
