ON MAY 15TH, THE YUGOSLAV GOVERNMENT ANNOUNCED A MAJOR ECONOMIC REFORM PROGRAM AIMED AT RESOLVING THE CURRENT ECONOMIC CRISIS. THAT PROGRAM INCLUDES: A SUBSTANTIAL LIBERALIZATION OF IMPORTS, CONTROL OF WAGES AND SALARIES, THE LIBERALIZATION OF PRICES, THE CREATION OF A FOREIGN EXCHANGE MARKET, ETC.
