As such, it was required to spect to travelling expenses for the fiscal assume responsibility for not only television and radio of all athletic events, many of which occurred simultaneously and at widely scattered venues, during the period of the games. The C.B.C. was also required to provide production facilities and staff assistance to foreign broadcasters. This work resulted in the production of 62 hours of television programming to Canada, United States and Mexico in English, French and Spanish; and of 233 hours of radio in many languages to all of the Americas, the Caribbean and parts of Europe and Africa. The financial requirements of so doing were as follows: direct costs of production-\$587,000; the use of staff and other regular overhead items when applied to the games on a standard rate basis-\$362,000; and the provision of temporary technical and production installations to meet special demands-\$307,000.

- 2. No facilities or equipment from C.B.C. maritime region were made available to assist in coverage of the Pan-American Games. Eleven TV technicians from Halifax, one radio technician from Moncton and one program clearance officer from Halifax were assigned to Winnipeg for various periods.
- 3. The 11-man technical crew from Halifax was part of the corporation's pool of personnel organized to cover major centennial events across Canada. Their involvement in the Pan-American Games was planned before the beginning of the year and they were in Winnipeg from July 26 to August 8. The radio technician was in Winnipeg from July 16 to August 8 and the program clearance officer was in Winnipeg from July 1 to August 10. Actual travel dates would have been finalized approximately three weeks in advance.
