SMALL BUSINESSES LOANS ACT

AMENDMENTS RESPECTING INTEREST RATE AND PROVISION OF FUNDS BY BANKS

Some hon. Members: Explain.

Mr. Howard: Mr. Speaker, I suggest that the explanation of this bill might also be taken to apply to the two other bills standing in my name so I will not take up the time of the House by dealing with each one separately. The purpose of these three bills, to amend the Small Businesses Loans Act, the Farm Improvement Loans Act and the Fisheries Improvement Loans Act, is to provide that the interest rate applicable to guaranteed loans made under these acts will be fixed at not more than 6 per cent, that the banks and other lending institutions shall be required by law to make available funds for loans under these acts in not less than the highest amount they have lent in previous years, that the Minister of Finance may require lending institutions to make more money available for loans under these acts if there is insufficient money available, and also to provide that farmers, small businessmen and fishermen shall have the right of appeal to the minister if their requests for loans are turned down.
