BUSINESS OF SUPPLY

ALLOTTED DAY S.O. 58—GOVERNMENT SPENDING— IMPLEMENTATION OF WILSON REPORT

Hon. Robert L. Stanfield (Leader of the Opposition) moved:

That in the view of this House, the government should set an example to other Canadians by forthwith indicating the nature and extent of the restraints on government spending and should also introduce without further delay measures to implement the Wilson report on the office of the Auditor General as an indication of its willingness to eliminate waste and extravagance.

He said: Madam Speaker, in this motion put forward by my party today we are asking the government to set an example for Canadians in the matter of restraints. The government should also take specific action in relation to the office of the Auditor General. During most of my remarks I intend to deal with the restraint aspect of the motion, under two headings. Others will deal specifically with the office of the Auditor General and recommendations will be made in that regard.

As I say, it is of great importance to the country that the government itself set an example to the people, in two ways. First, there must be real restraint. Here there is no room for new tricks with mirrors, or old juggling acts. Second, the public must perceive that the government has changed its own style of living, really believes in modesty of operation and is committed to it as a long-term way of life. So far, in the flurry and confusion of the first 17 days of the new renaissance, I have not seen examples of the government's determination to proceed on either of those
