some small way influence for the better the outcome. That continues to be my belief and my objective.

The tax issue will, without a doubt, occupy some of my attention in the days ahead. I do want you to know, however, Madam Speaker, that it is my full intention, subject only to the constraints of time, to continue to the best of my ability to represent the diverse and important interests of the people who sent me here.

Finally, Madam Speaker, I would like to thank the Prime Minister for his understanding and support in this matter. I thank the many friends who have come to my support, and through you, Madam Speaker, I would want to thank my colleagues in this House for allowing me this opportunity to provide this explanation.

Thank you, Madam Speaker.

#### FILING OF OBJECTION TO REPORT OF COMMISSION FOR PROVINCE OF BRITISH COLUMBIA

Madam Speaker: It is my duty to inform the House that an objection signed by the Hon. Members for Comox-Powell River (Mr. Skelly), Regina West (Mr. Benjamin), Selkirk-Interlake (Mr. Sargeant), Vancouver-Kingsway (Mr. Waddell), Winnipeg-Birds Hill (Mr. Blaikie), Winnipeg North (Mr. Orlikow), Spadina (Mr. Heap), Yorkton-Melville (Mr. Nystrom), Burnaby (Mr. Robinson) and Nanaimo-Alberni (Mr. Miller), was filed with me on June 29, 1983, pursuant to Section 20 of the Electoral Boundaries Readjustment Act, Chapter E-2, R.S.C., 1970, to the report of the Electoral Boundaries Commission for the Province of British Columbia.

If the House agrees, I would suggest that we follow past practice and print the text of the objection as an appendix to this day's *Votes and Proceedings*.

Is that agreed?

**Mr. Lewis:** Madam Speaker, may I suggest that it will determine whether or not it is in order to accept those objections and have them printed? If it is not in order to accept them, you will require unanimous consent of the House and we will want to consider that before giving it.

**Madam Speaker:** I had to assume that this was in order since it was referred to me by the Table. However, we can delay the printing of these objections until tomorrow when the matter is clarified.
