ALLEGED CONFLICT OF INTEREST—PARKER COMMISSION— REQUEST THAT OPPOSITION BE REPRESENTED AND PAID

Right Hon. John N. Turner (Leader of the Opposition): Mr. Speaker, I would like to put another question to the Prime Minister regarding the Parker inquiry. If we consider the precedent of the Estey Commission, the Government of the country is certainly going to be well represented, and as the Prime Minister has said, handsomely represented, by counsel at the Parker inquiry. Will the Prime Minister allow the Opposition to be equally represented at that inquiry and to be paid by the Government as the Government's own representatives will be?

Right Hon. Brian Mulroney (Prime Minister): Mr. Speaker, the Leader of the Opposition is asking me to intrude upon the jurisdiction of the Chairman of the inquiry. Representations can be made to the Commissioner under the Inquiries Act and he can make whatever determination he thinks is fair.

REQUEST THAT TERMS OF REFERENCE BE AMENDED

Right Hon. John N. Turner (Leader of the Opposition): Mr. Speaker, the Prime Minister knows that he can control the parameters of the inquiry by amending the terms of reference. Since it is quite obvious, because of the Estey precedent, that the Government will be represented at public expense by counsel, will the Official Opposition and the New Democratic Party be equally well represented and paid at public expense?

Right Hon. Brian Mulroney (Prime Minister): Mr. Speaker, we are not controlling any parameters. The inquiry has been asked to deal with the matters raised by my right hon. friend.

Mr. Turner (Vancouver Quadra): You set the terms.

Mr. Mulroney: Of course we set the terms as the Government must. When my right hon. friend was Minister of Justice, he was called upon from time to time to consult in that area on behalf of the Government. We have done exactly what my right hon. friend did when he was Minister of Justice in the

Government of Mr. Trudeau. Representations can be made to the Chairman of the Commmission and he will exercise the same good judgment in that as he will, no doubt, in all other matters. He is entirely free, and given his remarkable competence and impartiality, I am sure he will make the right decision.

CANADA-UNITED STATES NEGOTIATIONS—AUTO PACT INQUIRY
