Question No. 94—**Mr. Althouse:**

For each year since 1989, has Agriculture Canada undertaken field testing of genetically altered crops and, if so, (a) what tests were done (b) were environmental assessment studies carried out before each test and, if not, why not?

Mr. Milliken: Madam Speaker, I rise on a point of order. To say that I was heart broken to see that my question was not answered yesterday is putting it mildly.

On May 13, I placed a question on the Order Paper which I had previously placed on the Order Paper on February 25 this year. I asked for a 45-day response. It is still unanswered.

The hon. member for Lac-Saint-Jean was on his feet a little while ago asking about the situation in Montreal. I can understand why he was not asking about his constituency because my question asks about government largesse in that constituency in the by-election.

I ask what promises the government has made and whether they have been fulfilled. I think it is fair that the answer would not take eight or nine months. This is simply an abuse of the process, and I ask the parliamentary secretary to look into this matter and provide the answer at an early date. It has got past the stage where I

should have to rise and object. I have done so on two occasions before and have had my pleas fall on deaf ears.

Mr. Cooper: Madam Speaker, I thank the hon. member for raising his concerns. I must apologize to him. I am quite certain I signed that particular question off. I thought I had tabled it in yesterday's group. I will certainly check to see where it is because it was my understanding, if my memory serves me right, I signed off several over the weekend and I was quite certain that his was in that group. I will check.
